The proposed course on HANDLING THE MEDIA had to be abandoned due to lack of sufficient support to make it viable. A seminar dealing with BASIC INVESTIGATION SKILLS is under consideration, date and venue T.B.A. Correspondence courses covering INTRODUCTION TO UFOLOGY and BASIC INVESTIGATION are presently under development.
- PROMOTION A professional P.R.O. undertook to guide the promotion of BUFORA for nominal fees, sadly the experiment was short lived and has not been repeated. Bob Holland BSc, a physics lecturer has taken post as "INFORMATION OFFICER", and is doing excellent work, dealing with both membership enquiries, and a broad spectrum of correspondence requesting information on the UFO phenomena.

REPORT OF THE AUDITOR TO THE MEMBERS


YEAR ENDED 31ST AUGUST 1987.

I have audited the financial statements as published in the Official BUFORA Annual Report 1987. The audit was conducted in accordance with approved Auditing Standards having regard to the matters referred to in the following paragraph.

In common with many businesses of similar size and organisation the company's system of control is dependant upon the close involvement of the directors. Where independent confirmation of the completeness of the accounting records was not available I have accepted assurances from the directors that all the company's transactions have been reflected in the records.

Subject to the foregoing, in my opinion the financial statements, which have been prepared under the historical cost convention give a true and fair view of the state of the company's affairs at 31st August 1987 and of its excess of Income for the year then ended and comply with the Company's Act 1985.

As acting Honorary Treasurer. I am happy to present the Balance Sheet and Statement of Account for the past twelve months. You will see that whilst our income has increased, costs have also risen quite significantly.


To give you two examples. The Lecture costs have risen by approximately 35%, whereas Lecture income has risen by only approximately 4%, causing an overall loss.

Secondly, expenditure on publications has risen by approximately 53%, whilst income has only by 30%.

I hope that these two examples will help to illustrate the reason why the excess of income for the year was down compared to last year.

On a more optimistic note the Association's reserve fund invested in a Building Society has provided a worth-while income. We also finish this financial year in a healthy position at the bank.

I close as last year reiterating that <u>MEMBERS</u> are the life blood of an organisation such as ours, we must spare no effort to increase the membership base upon which all our activities are built.



MINUTES OF THE TWELFTH ANNUAL GENERAL MEETING OF BUFORA Ltd.

The twelfth Annual General Meeting of BUFORA Ltd was held at the London Business School, Sussex Place, Regent's Park, London, N.W.1. on Saturday 7th March 1987. The chairman, Mr. West opened the meeting at 18:43 in the presence of 30 voting members.

Before moving to the formal business of the meeting, Mr. West regretted that he had to announce the recent death of Miss Pam Kennedy, a long standing member of BUFORA who had served the Association in many posts over the years.

- 1. Mr West read the notice convening the meeting. No proxy votes had been received.
- 2. The minutes of the AGM held on 6th December 1986 had been previously circulated. Two minor amendments were proposed. Under item 10 it should read that Manfred Cassirer was elected to the Council, not co-opted. Under item 12, amanded should read amendment. Subject to these alterations it was proposed by Mr. H. Evans and seconded by Mr. P. Wain that the minutes be accepted. This was carried.
- 3. The Chairman's report had been previously published in the January 1987 BUFORA BULLETIN. Mr. West added that he had approached Professor Archie Roy to become the President of BUFORA. A reply was awaited. He also added that it was hoped to arrange a workshop at the forthcoming Congress to discuss updating the Investigators Code of Practice. A survey had been sent out with the January BULLETIN, which had generated so far 30 replies.
- 4. Mr. West had been acting as treasurer for the past year and presented the Accounts. There was an excess of income over expenditure of £475 on this year, with £2833 carried forward. Mr. West reported that membership had dropped by about 60 over the year, hence the lower membership income.
- Mr. P. Wain proposed the adoption of the accounts and the auditors report, seconded by Miss F. Farquharson. Passed unanimously.
- 5. Proposed by Mr. K. Phillips and seconded by Mr. M. Wootten that Council be given leave to appoint the auditor and fix his renumeration. Passed unanimously.
- 6. It had been proposed at the 1986 AGM that the quorum for the AGM be lowered. Mr. Cassirer moved the motion stating that on many occasions the meeting had been delayed in starting due to the lack of a quorum. This had been set when BUFORA had more members. Mr. Beer suggested that if membership increases then the quorum should be increased. Proposed by Mr. Cassirer that the quorum for the AGM be reduced to fifteen members, seconded BUFORA Winter Newsletter December 1987 Page 9.

by Mr. Beer. Passed, 23 members voting for the motion, 6 against.

7. The following members of Council retired by rotation and being eligible all presented themselves for re-election:

Mr. Hilary Evans, Mr. Kenneth Phillips, Miss Jenny Randles and Mr. Mike Wootten.

In the absence of any further nominations it was proposed by Miss F. Farquharson, seconded by Mr. J. Spencer that they be re-elected. Passed unanimously.

A.O.B. Mr. Cassirer asked that Council investigate the possibility of becoming a registered charity.

The Chairman closed the meeting at 19:10.

CHAIRMANS REPORT

There is little point in my re-iterating those routine matters dealt with in the Report of the Council, rather I would report some recent developments within BUFORA, and bring you up to the present time.

After years of excuses, I confidently expect to ask the newly appointed President to open proceedings at the AGM. I should say that he has a military background and wide experience of public life, which combined with long interest in UFO's make him eminently qualified to lead BUFORA into the next decade.

Several members retire from Council as from this AGM. After many years service in various capacities, including vice and full Chairman, congress organiser, lecture organiser, etc, Lionel Beer feels in need of a break, the Council are pleased that he has accepted post as a Vice President of BUFORA, as a token of appreciation of his services to BUFORA. Ken Phillips is resigning from his many duties in BUFORA, including at various times Training Officer, Lecture Officer and of course a diligent researcher engaged in development of interesting new investigation methods. After three years battle with ill-health, Robin Lindsey is taking a well earned break from Council, but will continue to operate the Tape Library, and to record public lectures whenever possible. We express our gratitude for the dedication of Lionel, Ken and Robin, and wish them well.

The Lending Library is now set up with Michael Hudson, about 160 books are available for loan by Members, applications in the first instance to the Registered Office.

R.D. (Bob) Holland is providing an excellent service handling both membership and general information enquiries, and is also engaged in compiling a correspondence course suitable for both members and investigators.

The fine "UFO's 1947-87" was published to co-incide with the 1987 International Congress, and the publications department have exciting plans for the new year.

Credit too to Bob Digby (then of Eyecatchers A.V.) for the fine International Congress held at the L.B.S. in July 1987. Delegates from around the world attended the wide range of events offered.

We are recommending a small amendment to the Articles of Association to permit the co-option of suitable persons Council. This will facilitate the use of specialist advisers, and allow easy liaison with other bodies.

On a sad note, may we pay our respects to Charles Bowen, past editor of the "Flying Saucer Review", who passed over on 14th October 1987. May he rest in peace.

I would thank all Council Members, Officers, Investigators and other helpers of BUFORA for their hard and loyal service during the past year, and look forward to working with them in the coming year.

REPORT OF THE DIRECTOR OF INVESTIGATIONS

In the year March 1987 - March 1988 the BUFORA Investigations department has continued to function under the auspices of the NIC (National Investigations Committee). This comprises as voting members all Accredited Investigators (AIs), guests and investigators from friendly groups. No meetings are closed and reports are summarised in BUFORA BULLETIN.

The NIC during the year comprised approximately 22 AIs, representing about one-tenth of the BUFORA membership and covering most of the country. We have lost several members, notably Robert Moore (who has moved into a research team job) and Mike Wootten (who decided to quit as London area RIC to concentrate his time on the BULLETIN). In the same period we have gained several provisionals and a number of new AIs, including Phillip Mantle in Yorkshire (ex YUFOS and the UK representative for the major American group - MUFON), Susan Pollock from the Northamptonshire network and Malcolm Robinson (in Scotland) who took over as RIC at the start of the year. Albert Budden has replaced Mike Wootten as Greater London RIC.

The year was dominated by the 40th anniversary of the first 'flying saucer' sightings, the incredible hiatus in the USA over both the MJ-12 documents and abductions typified by Whitley Strieber's book "Communion" plus, of course, BUFORA's own extensive efforts in the congress and publication fields.

Press cuttings reached an all-time high with a total of 500 for the year easily beating the previous 'best' year (1983). However, much of this was promotion for the religious cult, the Atherius Society, who had a major publicity drive. The NIC had to counteract some of this with serious interviews on radio, television and in the media... including a piece promoting the NIC in Police Review!

Approximately 50 new cases were added to the files, but many more are beginning to flow in as the result of a wave of sightings during August 1987. That month produced more BUFORA Winter Newsletter December 1987 Page 12.

sightings than any other since 1980 and in fact more than the entire YEAR of 1986! Many were lights in the sky and a large number were explained as due to a NATO exercise using airborne refuelling and the infamous London 'UFO kite' which was used extensively as part of a weekend in Mid-August when a scientist predicted the world would end. Our investigations into the prophecy thankfully concluded that this was a slight exaggeration.

However, and despite the amazing publicity, there were no new major close encounters promoted during the year... although one CE3 in Lancashire, a bedroom visitor with a Streiber type entity in Cheshire, a car-stop case in Derbyshire and a major abduction with gynaecological features from Yorkshire are all unpublicised but under investigation.

Reports on NIC cases featured quite extensively in the major media sources during the year. These included the 'mystery circles' (October) in OMNI (New York), the Rendlesham Forest case on BBC-TV (July) and the Ventnor, Isle of Wight case in the Sunday Express (December). The NIC was also extensively involved with BBC-1 in putting together a 35 minute discussion programme on UFOs, screened on 26 November 1987 in the Kilroy series. The Director of Investigations was an official research consultant for the BBC. Several BUFORA investigators, including Albert Budden, Ken Phillips, Mike Wootten, Andy Roberts and Phillip Mantle took part in the debate and several major cases were discussed.

During the year the NIC also purchased a computer software package which is being adapted to produce a system that offers probability ratings for various IFO options. These will be an invaluable adjunct to the human side of the equation, with AIs continuing to evaluate cases themselves.

NIC publications consisted of an update report by Paul Fuller and Dr Terence Meaden on the 'mystery circles' reporting the jointly funded project between BUFORA and TORRO (a meteorological research unit) which was conducted in the winter of 1986-87 (circle 'off season'). This unique effort now provides a major addendum to the 1986 NIC publication "Mystery of the Circles" and is, in our view, evidence of how ufologists should be tackling this subject. Too many groups or magazines are still incessantly writing on the matter in UFO terms without conducting any scientific research.

There was also the second edition of our new annual ("UFO World '87") and by the time you read this the first in our new series of once or twice annual 'Case Histories' will be published, entitled "Fire in the Sky" and reporting our work on the Peter Day movie film.

After several technical problems with the publishing hardware used to produce the Bulletin, that has delayed its publication, BUFORA has purchased a new desk top publishing system. We hope that this will enhance the quality of our publications and deliver them on time. The Journal of Transient Aerial Phenomena has continued a policy of presenting a quality Journal with a scientific base.

BUFORA publications has a bright future with new ideas in the pipeline and we shall continue a policy of producing publications of high standards of both presentation and content.

The Council of management thank all who have devoted much time producing the publications mentioned above, from authors to printers.

REPORT OF THE RESEARCH DEPARTMENT FOR PERIOD ENDED 31/8/87.

- 1) During this period S.Gamble has continued in the capacity of Director of Research.
- The primary work of the department has been concerned with research into UFO and associated phenomena, and the support of field investigators.
- 3) During the year two meetings of the research committee were held. In addition, representatives of the research department attended meetings of the national investigations committee.
- 4) Mike Wootten has continued work on the computerised indexing of case reports. He has been helped in this by a number of members and has received further offers of help.
- 5) Paul Fuller has continued his work of circular damage to fields of cereal crops. An extensive survey amongst cereal farmers in southern England has been conducted.
- 6) Nigel Smith has continued to head the photographic and traces group. He has been assisted in this by Roger Chinery and Steve Gamble.
- 7) The department has continued to monitor use of computers for UFO research. This is monitored by Paul Fuller using forms previously published in both BUFORA BULLETIN and JTAP.
- 8) Two issues of the Journal of Transient Aerial Phenomena have been issued during the year.
- 9) Nigel Smith has been working on a jointly funded project between the Research and Investigation departments on the interpretive powers of witnesses.
- 10) A further grant has been made towards the Witness centred project of Ken Phillips and Alex Keul.
- Mike Wootten, assisted by Gaynor Sunderland, has continued work on refurbishing the case report files.
- 12) The following people have assisted Steve Gamble in the work of the research department: Roger Chinery, James Danby, Robert Digby, Paul Fuller, Julie Hancock, Mike Hudson, Robin Lindsey, Ken Phillips, Nigel Smith, Gaynor Sunderland, Mike Wootten and Arnold West.
- 13) During the year, BUFORA's registration under the data protection act was approved.
